**Sub - Orders to prevent the infection and spread of the Covid-19 (Corona virus):-**

**ORDER –**

(In 1st para, he has explained the prevailing situation of Corona in India and why it's necessary, that we take precautions & stop the spread of Corona)

2nd Para – In view of above situation, I am **Mr. Naval Kishor Ram, District Collector, Disaster Management Board Cum District Civil officer Pune, as per Disaster Management Rule 2005 and similarly using power under Maharashtra Police act 1951, I am hereby directing Ban / Restriction till further notice as under -**

1. To Close All kinds of ceremonies, cultural and religious events, festivals, celebrations, urus, jatra, entertainment programs, sports and all other competitions, etc., which will be celebrated in the Pune District, where more than five or five persons will be gathered in private and public places.
2. To Close All kinds of activities like workshops, camps, training classes, meetings, procession rallies, meetings, protests, tours like Pune Darshan, domestic and foreign tours, etc., besides the essential ones, where five or more persons will come together in private and public places in the Pune district area. Other government meetings will be forbidden.
3. To Close Shops located in Pune District Jurisdiction, Service Establishments/ Caterers / Foods / Eateries, Shopping Complexes, Malls, Supermarkets, Recreation Places, Clubs / Pubs, Playgrounds, Grounds, Swimming Pools, Gardens, Cinemas, Theater, Schools, Colleges, Schools, Colleges Gymnasiums, museums, video parlors, online lottery centers, etc. will be closed
4. To Close All permit rooms in Pune district, Beer bars until 31/03/2020.
5. All citizens will be prohibited from visiting unnecessarily in public places without a prescribed reason.

**Above order will not be applicable to following:-**

- 1) Government, Semi Government offices, Government undertakings
- 2) Person working in essential services, Hospitals, pathological Laboratory, Clinic.
- 3) All types of medical and nursing collages,
- 4) Railway station, Bus Depo, Bus stop, Airport, Auto Stop, etc,
- 5) Funeral cemeteries
- 6) Essential grocery, Milk Product, Fruits & Vegetable, Medicine & Other essential sales & distributions
- 7) All Hotels / Lodge
- 8) Mess & canteen for students & Hotels.
- 9) Examination of 10th 12th
- 10) Only those Information and Technology Sector establishments/companies who are entrusted with responsibility of important Critical-National & International Infrastructure programs and closing of such companies may hamper all such programs, may remain open. It has been made mandatory that District Collector office should be 'specifically communicated' about the need to keep such companies functional/operational.
- 11) Media communication (all daily newspaper) Magazine, TV News etc, etc will function

If anyone violates above, necessary action will be taken against him under IPC 188 & Disaster Management Rule 2005.
