### CIRCULAR

**Sub.: Notification U/S 1(5) of ESI Act 1948 in respect of "Establishments" in Maharashtra Region for coverage of Medical & Educational institutes-reg.**

**Ref.:** This Office Circular of even number dated 11.02.2026 on the above subject.

In continuation of this Office Circular cited above, attention is invited to the Government of Maharashtra Notification No. PHD-12016/3/2025-PHD (R.K.V. 2), published in the Maharashtra Government Gazette, Extra Ordinary No. 69, Part IV-A, dated 31.01.2026, regarding extension of the provisions of the ESI Act, 1948 to Educational and Medical Institutions employing 10 or more persons.

Subsequently, the State Government has informed that the Law and Judiciary Department has pointed out that the Employees' State Insurance Act, 1948 has been repealed by the Central Government and the Code on Social Security, 2020 has been brought into force with effect from 21.11.2025. In view of this, the State Government has initiated action to cancel the aforesaid notification dated 30.01.2026 issued under Section 1(5) of the ESI Act, 1948.

Accordingly, as per the directions of the Government of Maharashtra, all field offices are hereby instructed to keep in abeyance the implementation and further action under the said notification until further orders.
